Brambles growing	Cut or scrape from contact with brambles	2	2		Children reminded not to touch nettles, thistles and brambles. Class teacher to remove any clear hazards and highlight to children where to go/not to go. First aid administered if required. Children wear long clothing to avoid being scratched.
Bees or wasps in FS area	Sting from bees or wasps when outside	3	3		No known allergies to wasps/bees or plants. Children not to consume plants. First aider and first aid kit available. Children reminded not to collect bees and wasps when looking for minibeasts.
Slip on mud	Children slip and hurt self	2	2		Children reminded to walk around FS area and to look where they are placing feet. Staff to encourage children to use alternative routes if very muddy parts.
Trip/slip on uneven ground or tree roots/stump	Slipping and falling over uneven ground. Cuts and grazes.	2	2		Pre warn children of slopes, tree roots and uneven surfaces, and to look where walking at all times. Ask parents for sensible footwear, e.g. welly boots or outdoor shoes with grip. First aiders and first aid kits available. Children to walk around FS area.
Hit by low level branches at eye height	Injury to face, head or eye from low level branches	3	2		All low level branches to be identified (red ribbon) and reported to FS leader/assistant. FS leader/Assistant remove if required. All clear obstacles to be discussed with the children. All children reminded to look and walk around FS area.
Standing in/touching excrement	Contact with cat, hedgehog and bird poo	1	3		Children reminded not to touch or pick up animal faeces. If children step in this, shoes are to be cleaned using wipes and adults/children to wash their hands. Class teachers to check and remove animal faeces before session begins.
Hurt by slipping or bumping into log circle	Bruises, cuts or grazes from contact with wood.	3	2		Children reminded to walk around FS area and never to cross FS circle. Obstacles and slippery areas to be discussed with children. First aid administered if required.
Eating vegetation growing, e.g. berries, leaves, bark.	Choking, upset stomach, allergy.	3	2		Children reminded not to eat leaves, plants or pick up anything from ground and put in mouth. All adults to monitor children. All adults to supervise group in water. Children to wash hands when return to classroom.

Children to be given plenty of opportunities to drink water. First aid administered if required. FS area has some natural shelter from tree canopy. Children return to classroom if needed.

First aid administered if required. FS area has some natural shelter from tree canopy. Children return to classroom if needed.
Exposure to adverse weather – wet	Slipping on wet ground when raining	3	2		FS floor becomes slippery when wet. All adults and children to be wearing sensible footwear. Appropriate supervision in FS area. Children wear own waterproof clothing if weather is forecast rain. Spare clothes to be requested from parents (call home) for children to change into if become saturated.
